# PUBLIC POLICY AND ADMINISTRATION, MA

The Master's in Public Policy and Administration requires the successful completion of 13 courses to obtain a degree. Students complete ten core courses, including a capstone or thesis, and three elective courses. ## **About the Final Project**

Students may pursue their capstone experience independently or as part of a team. As their final course, students take either the individual
